Any services or materials not specified above, including any subsequent written change orders, shall be charged on a minimum hourly basis of \$65.00 in addition to the Contract Amount. Any amount unpaid balance will accrue interest at the rate of one and one-half percent per month. In the event of collection of any overdue amounts, the unpaid balance will be augmented by collection costs and reasonable attorney’s fees. The venue for any disputes shall be a court of competent jurisdiction in Washington County, Utah.

This Agreement comprises of the entire agreement between the parties. No oral representations or agreements shall be binding upon the parties unless set forth in this Agreement or are supported by a written amendment to this Agreement which is signed by CRI. Likewise, this Agreement cannot be modified or amended except by a written amendment signed by CRI.

It is understood and agreed that this Agreement does not cover conditions which are not observable or detectable without entering closed walls, covered by floor coverings, or digging below the ground level, including septic or sewer systems. These services are not any warranty or are not breached by any failure to discover the presence of insects, rodents or other pests, or damage caused by any of these, unless such damage can readily be detected by visual inspections that does not require the moving of furnishings, fixtures, appliances, appliances or anything which would require drilling. These services are not provided as governmental code compliance inspections or approvals. CRI is not an insurer against loss or damage to personal property or the real property. Customer is solely responsible for procuring and maintaining adequate insurance policies to insure against loss or damage due fire, theft, earthquake, flood, and other casualties and general premise liability insurance. In the event that CRI were to be accessed any liability or fault due to its negligence by a court of competent jurisdiction, such liability shall be limited to the lesser of the amount assessed by court order or five hundred dollars.
